<p>General Comments</p> <p>Upon arrival of licensing staff, the infant room was cleaning up. The educators were helping the children. The educators changed diapers and got the children set up for snack. The 2-year-old group was sitting down having snack. And the 3 and 4-year-old group were reading a book with an educator. The educator was showing the children the book to keep them engaged. All the classrooms then started getting dressed to go play outside.</p> <p>When the infants returned inside, the educators helped them get their snowsuits and boots off. The children and educators played with cars, music instruments, babies, and animals. The educators were sitting with the children and were heard singing to them. The preschool groups continued their play outside. The children were observed playing in the kitchen, making mud balls, and with ride-on cars going around the yard. The educators were engaging in conversation with the children. The educators would bring children inside for washroom breaks when needed.</p> <p>In the infant room, the educators changed diapers and washed hands for lunch. The educators got the children settled in their highchairs and helped prepare their lunches. The educators assisted the children and were talking kindly to them. The preschool groups returned inside for lunch. The children got their snowsuits off, washed their hands, and got settled at the table. The educators helped the children, and some educators prepared their nap cots. The educators got the infants settled down for nap.</p> <p>The daily information sheets are completed for the infants. Staff files were checked and found to be complete. Child files were also checked. Please ensure immunization records are printed and added to the files and ensure Medicare information is updated. The walls are decorated with recent learning stories, artwork, and pictures of the children. Positive child guidance was observed.</p>
