General Comments
<p>Monitoring Inspection:</p> <p>Children and educators observed engaged in a variety of activities this morning both indoors and outdoors. The infants were observed exploring a variety of materials freely within their environments. A variety of age-appropriate loose parts and real-life items are arranged on low open shelving in a way that encourages infants to explore. The junior preschool was observed listening to a story; read to them by their educator and they took turns experimenting with the sounds of a small steel drum. The preschool children were observed in the outdoor play area exploring watercolour paints on a block of ice.</p> <p>Purposeful planning is evident through documentation, invitations and materials added to the environments that support the children's current interests (stickers, snow, books, animals, climbing, throwing and cooking). In the preschool room educators have created a Tuff Tray sensory small world that includes photos of the children "skating" - paper clips have been added to the photos and magnetic wands are available to allow the children the opportunity to investigate how magnets work as they make their photos "skate".</p> <p>The administrator was observed supporting staff during the transitions to outdoor play and during washroom routines.</p> <p>Pulled pork, mashed potatoes and corn were served for lunch.</p> <p>Handwashing routines were observed during washroom and diaper changing routines.</p> <p>Monthly fire drills are documented.</p> <p>Daily attendance records are accurate and reflect all children present. Child-to-staff ratio was observed to be met during Monitoring Inspection. Infant daily information sheets are completed throughout the day.</p> <p>Infants are held by educators during bottle feeding.</p> <p>New staff file (4) review was completed.</p>
