General Comments

Children were engaged in free play and getting ready for snack this morning. Attendance records to reflect all children and educators within each room throughout the day.

One child in the infant room was falling asleep in a chair. Ensure children's developmental needs are met for sleep and in consultation with families. Children that require a morning nap can involve a relief staff or administrator to ensure 15-minute checks are completed.

All the children went outside this morning. The children in the infant play space had a variety of resources. One educator played children's songs and nursery rhymes for the children to dance and move to. The infants were a very happy group today as the educators were engaged talking with children, encouraging, and providing opportunities for play. In the infant play area, there is a sand box that needs to be replenished with sand and a water table that the educators fill with water. There is a large spool table in the infant area and two in the preschool space that need to be repaired or replaced as they are showing splintered wood.

The preschool outdoor space has lots of opportunities for climbing including a climbing wall. One of the pegs on the climbing wall is loose and needs to be secured. The gravel in the preschool space is bare in some spots and requires a good raking. There is a wooden coffee table in the gazebo that needs to be replaced.

There is a pile of old resources beside the preschool play space that needs to be cleaned up. The preschool educators were blowing bubbles with the children, sitting in play, and running around with the children on the playground.

Remember that children's hands should be washed when coming in from play outside.

One of the educators in the 3-year-old room joined the children on the room for carpet time which the children were eager to go to. The educator showed a video of One, Two, Buckle my shoe and then had a discussion with the children about the color of their shoes.

Ensure the carpet in the 3's space is properly shampooed.

After coming in from outside, children were eager to start lunch and begin quiet/nap time. The educators help children as they fall to sleep with back rubs or sitting in the chair with them.
