## **General Comments**

The outdoor play areas have been cleaned up and the garbage removed from beside the play space. Any items that were broken have been repaired or replaced.

The children all went outside this morning for a walk or play in the outdoor play space. Children enjoyed their lunches and some free play before nap time. Educators asked a question about the ratio during lunch periods for children over 2 years of age and some solutions offered to maintain ratios and allow children that are napping to have an uninterrupted sleep.

Recent documentation was evident throughout the infant rooms with children's artifacts posted on lines and the

wall. Learning stories have photos of children, connections to the curriculum and highlight children's learning. Children's quotes are included in the documentation and show exploration with bugs, celebrating children's success, and representing all the children in the room.

Some of the curtain rods have been secured with holders however, tape was used on others and is falling off and not a suitable solution.

A new gate has been added in the infant rooms and new resources and room arrangements are evident in each room making the space more inviting and accessible for children. Educators were engaged with children throughout the day with many educators sitting to eat lunch or snacks with children. Cleaning was evident in each room as educators cleaned tables and swept the floor, as needed throughout the day.

Remember to keep attendance records up to date at all times and label water bottles for children to reduce confusion with relief staff.
