General Comments

Name of operator

Children were eating snack when licensing staff arrived. Children clean up their snack bags and place them on a shelf when finished. Educators supported children's independence by asking "What are we going to put away next?" Educators regularly asked children if they needed to go to the washroom and would take several children at a time. Parents arrive and bring their children into the room, putting book bags away, and getting indoor shoes on. Parents washing hands upon entry was not viewed but they do pass a washroom on their way in and this might be part of the routine.

Educators were down at the children's level and excited about play with children evident in their engagement, language, and physical closeness and cuddles.

General Comments

Documentation was evident in the three-year-old room with photos of the children, artifacts posted, an All About Me wall, and learning stories. A way to add to documentation is including children's names in the description and quotes from the children. One of the educators and licensing staff discussed the plan for the week focusing on spring. The educator brought out a large piece of paper this morning and made a paper airplane connecting an educator's trip on a plane. The educator mentioned this was a spontaneous decision but children were very interested and a great opportunity to connect to what is happening with educators in the centre. Children showed interest in sharks this morning and licensing staff found some shark books on the centre's bookshelf to share with the children. Several children sat to read the books and then an idea was suggested to draw their own sharks. The educator provided white paper and crayons on a table with the books for inspiration for the children interested and also added a small toy shark. Connecting picture books to children's interests is an important way to support literate identities.

Children in the two-year-old room were painting on white sheets of paper taped to the table. They had water, watercolors, and paint brushes. When children were finished the paper was ripped up and thrown in the garbage. The recommendation would be to have one large sheet of paper that could be posted after children are done painting to value their art.

The educators in the two-year-old room take turns planning curriculum and one learning story was posted with curriculum connections and photos. Licensing staff and an educator discussed moving photos of children and documentation down on the wall so children can revisit their learning. Their plan for the week is the very hungry caterpillar and they have planned activities and ideas to support this interest. They also mentioned an interest in rain and encouragement was given regarding going outside so children can have bodily experiences in rain and puddles to support their learning. Parents can be reminded to provide appropriate outdoor clothing for children especially during transitions between seasons.

The educator provided alternatives to children when there were disagreements about resources and the space provides lots of opportunities for gross motor play by climbing, jumping, and stepping. The educators were viewed cleaning the table after play and sanitizing their own hands after wiping noses.

In the infant rooms, there were numerous learning stories posted on the windows making connections to the curriculum and highlighting the rich learning of children. Children's artifacts are posted throughout the space showing the open-ended art activities children engage in. Children went to the washroom before lunch or had their hands washed and bum changes after lunch.
