Ratio was respected during the visit.</p> <p>During the visit, infants, preschool and school aged children were observed in free play and participating in planned activities. Diaper changing, outdoor play, nap time and mealtime were also observed.</p> <p>The facility will meet requirements under the Act and regulations once the administrator and at least 50% of educators hold a one-year Early Childhood Education Certificate or training that is equivalent. The licence is recommended for another year.</p>
