Comments: Inspector reviewed mandatory attendance records. Two children who were napping in Room 2 were not signed into the attendance records. When children move to another room for napping/quiet time/ end of day, they must be signed out on the attendance records in their original room and signed in on the attendance records in which room they currently occupy. Discussed with Campus Director, Administrator and Educators during the inspection. Educator signed the two children in on the attendance record during the inspection.

Comments: At the monitoring inspection, Inspector observed that all toxic products were securely locked out of the reach of children. Deficiency is now compliant

A monitoring inspection occurred today.

The children were observed during nap/quiet time, outside play time and afternoon snack.

The Early Learning environments in each of the rooms were set up with a variety of age-appropriate natural materials for the children to interact and engage with.

Children were also observed in their outdoor classrooms in the "Vanished Kingdom". Children were enjoying their afternoon snack with their peers, playing with sticks and climbing rocks.

Discussed with Campus Director, diaper changing routine and recommending that this is reviewed with all Educators to ensure the proper procedures are being always followed.

Inspector reviewed all new staff files to ensure complete and accurate.

Educators in the four rooms were observed speaking positively and kindly to the children and engaged with them in their learning and play.
