General Comments

A monitoring inspection was conducted on October 29, 2025, on this school age license. During the inspection and while taking ratio, Inspector observed and recorded that between the two groups of children there were 49 children present. This license is approved for a maximum of thirty children. Upon speaking with the Chief Operations Officer and School age Administrator it was determined that the children from this license, 2024081, which is approved for thirty school-age children are mixed with the school-age children from license 2020041, at the end of the school day at 3:00PM. License 2020041, is approved for 20 preschool and 40 school age for a maximum of 60 children. At the end of the school-day, the children from these licenses are combined outside to form one group. The Inspector observed two sets of attendance records. One for the K-Grade 2 group and one for the Grades 3-6 group. Chief Operations Officer indicated that when then children are inside, they are broken into their respective groups with educators for each group/license. The K-2 group had twenty-eight children in their group with two educators, the Grades 3-6 group had twenty-one children with two educators. Ratio was observed maintained in these groups. However, the inspection was only conducted on license 2024081 which is approved for 30 school-age spaces. By mixing the children from license 2020041 and 2024081 to form two groups under one license exceeds the maximum approved for the license 2024081. A plan is to be created to ensure the maximum for each license is not exceeded when outside. Children in these groups were observed climbing trees, exploring the wooded area adjacent to the childcare centre, playing soccer, creating "monsters" with art materials and hanging and socializing with their peers. Inspector observed the educators in these groups redirecting children appropriately using positive child guidance techniques, speaking kindly to them as well and helping them problem solve.

A monitoring inspection occurred on November 7, 2025, to follow up on the inspection from October 29, 2025. Operator has divided the groups to ensure that the maximum group size for the license is not exceed. Inspector observed that attendance records have been created to reflect this change. Facility is in compliance.
