### General Comments

A Monitoring Inspection occurred on June 12, 2025.

Children were observed during snack time and outdoor free play. Proper handwashing procedures were followed during the transition to snack. Steps and platforms were available to support children in accessing regular-sized toilets and sinks. Books reflecting the children's interests were available, and various forms of literacy were present throughout the indoor environment. Children's portfolios were in progress, and children had access to them. Several forms of documentation were visible across the facility. Well-defined learning and play areas were observed, and children's artwork was displayed throughout the facility.

Educators shared that the children are currently interested in making Father's Day art, being active outdoors, exploring the lifecycle of bees, and engaging in sensory play with water and loose parts in the outdoor mud kitchen. Educators were observed playing an active role in outdoor activities and supporting children's engagement in learning and play.

The daily routine was posted in each room, and evacuation procedures were visible and located in prominent areas. Monthly emergency evacuations were completed and documented. A clearly visible area was used to post the facility's license, current inspection and monitoring reports, and any orders for compliance. The outdoor environment was well maintained—traffic areas and walkways were clean and free of clutter. Outdoor stationary equipment was surrounded by protective surfacing of appropriate depth.

Toxic products, including chemical cleaners, were locked and inaccessible to children. The diaper changing area was within one metre of a sink, and procedures were posted and visible to those completing a diaper change. Drinking water was made available throughout the day. A daily incident log was maintained. Parents were notified of any incidents, and incident report forms were completed for any reportable occurrences. Outdoor play occurred for at least one hour in each four-hour block of time when the majority of children were present, weather permitting.
